Small business, we've got your back. We're Texas Back in Business - the \$100 million Hurricane Harvey relief program for Texas small businesses. Starting Monday, December 2, at 8 a.m., you can begin applying for grants related to business losses incurred from Hurricane Harvey online at [TexasBackInBusiness.com](http://TexasBackInBusiness.com). Grants range from \$50,000-\$250,000.

### **Who is eligible to apply?**

1. Were you in business on August 25, 2017, when Hurricane Harvey hit Texas?
2. Did your business suffer losses due to Hurricane Harvey?
3. Are you a small business as defined by the Small Business Administration (SBA)? [Click here to see small business designations](#)
4. Is your business located in one of the 49-counties impacted by Hurricane Harvey? [Click here to see eligible counties](#)

If your answer is "Yes" to these 4 questions, you are eligible to be considered for a business grant for up to \$250,000.

### **What is Texas Back in Business?**

Texas Back in Business is funded by Congress through the Department of Housing and Urban Development. Authorized by the Texas General Land Office, Texas Back in Business is the Hurricane Harvey relief program for Texas small businesses. Texas Back in Business is NOT a bank and is NOT affiliated with the SBA. Texas Back in Business is the economic revitalization program created to help Texas small businesses affected by Hurricane Harvey create jobs and get back on the road to recovery.

### **How are grant amounts determined?**

The amount of funds your business may be eligible for will be determined by several factors: remaining need and job creation or retention, especially for low- to moderate-income individuals.

Applications will be accepted from December 2, 2019 to March 2, 2020. Applications will be chosen at random for an eligibility and underwriting review after the application period concludes.

Best of all, if your business is awarded funds and fulfills the requirements of the grant, no repayment is required.

### **What information is necessary to start your application?**

1. Your contact information.
2. Information about your business, such as, type of business, location, number of employees.
3. How your business was damaged (economically/physically) by Hurricane Harvey.
4. How the grant funds will be used to assist your business.
5. Other types of relief you have applied for or received.

Once your application has been reviewed and your business has received initial eligibility clearance, you will be contacted for additional information.
